General Statement

The NJ Association for the Treatment of Sexual Abusers (NJ-ATSA) is sponsoring a membership scholarship initiative, and will pay NJ-ATSA and National ATSA dues for two individuals for the coming year.

NJ-ATSA, a state chapter of ATSA - an international non-profit organization, currently provides training and networking opportunities for professionals who work in some capacity with sexual abusers, (e.g., clinicians, administrators, law enforcement).

The membership scholarship initiative is designed to facilitate sex offense-specific training and networking opportunities for clinician and clinical student interns who are new to the field, and to continually strive to meet national ATSA's mission to further professional education and provide for the advancement of professional standards and practices in the field of sex offense evaluation and treatment.

Goal

By financing memberships for NJ-ATSA and National ATSA, NJ-ATSA intends to support the professional development and engagement of new clinicians and/or clinical student interns.

The overarching goal is to increase NJ-ATSA and National ATSA membership to advance the field by facilitating specialized training, networking and development of new clinicians who work with individuals who have engaged in sexually abusive behavior.

To effectively achieve this goal, NJ-ATSA's existing Grant Scholarship Committee will review applications and select recipients.

Eligibility

- A new clinician, (i.e., less than 5 years' clinical experience), or clinical intern who is working with sexual abusers.
- Nomination by a NJ-ATSA member, or self-nominated.
- Making a demonstrable contribution to the field.
- Regular attendance at NJ-ATSA meetings.
- Intent to continue NJ-ATSA and National ATSA membership beyond the one-year period.

Procedures

Applicant:

To be considered, an applicant must:

- Complete the application form, (see www.njatsa.org); additional pages may be attached if needed. (*Please see application form for the current deadline for submissions.*)
- Include in the application current contribution to the field.
- Acknowledge intent to continue NJ-ATSA and National ATSA membership beyond the one-year period.
- Provide additional information if requested.

The awardee must additionally agree to:

- Announcement of the scholarship award, e.g., verbally at a NJ-ATSA meeting, via email or social media.

NJ-ATSA:

Under the auspices of the NJ-ATSA Board, the Grant Scholarship Committee will:

- Advertise the start and end dates for submissions.
- Ensure availability of current applications.
- Provide contact information for a point person to collect applications and address any questions or information requests.
- Collect and review all submissions.
- Announce all recipients.
